



## RESTAURANT AWARDS 2018

### SILVER FERN FARMS RESTAURANT AWARDS 2018 FURTHER TERMS AND CONDITIONS

#### ACCEPTANCE OF TERMS

Participation in this competition is deemed acceptance of these Further Terms and Conditions.

#### Competition

1. To enter the competition, entrant chefs must create an original dish using a Silver Fern Farms Lamb, Beef or Venison cut. The dish must be placed on the menu in the restaurant in which that chef works and be available to be ordered during the period 8 March to 12 April 2018 inclusive (for finalists this period extends through to 31 July 2018). The dish shall be identified on the menu or in writing at the restaurant table as being an "Entrant in the Silver Fern Farms Restaurant Awards".
2. Each entrant acknowledges that the cut selected may not be available at all times, however Silver Fern Farms will use all reasonable endeavours to make the cut available for the judging period.
3. Entries are submitted via the online entry form and all fields must be completed and a photo of the dish supplied. The photo and information supplied may be used for promotional purposes by Silver Fern Farms and its agents.
4. Entries are to be made by individual chefs (not teams). Only one entry per restaurant is permitted unless an entry is made by both a chef and an Emerging Chef from the same restaurant. An Emerging Chef is a chef who has worked for no more than 5 years as a cook, chef or similar. Only New Zealand-based chefs are eligible to enter.
5. Chefs entering the restaurant in which they work in either the Restaurant of the Year or Regional Restaurant of the Year category confirm they have the authority to do so.
6. A Regional Restaurant is a restaurant in a town having a population of no more than 40,000.
7. Entries open on 15 January 2018 and must be submitted by 5pm on 15 February 2018. Entries received

after this date will only be accepted at the discretion of Silver Fern Farms.

8. Restaurants shall ensure all staff are informed of the competition and the entry dish, and can discuss each with the restaurant's customers.
9. Entrants are required to provide two entry dishes (only) free of charge to judges during the judging period. Judges will identify themselves after the meal and provide appropriate identification.
10. Finalists will be announced on 1 May 2018. Unsuccessful entrants will be notified via email.
11. Silver Fern Farms will attempt to advise each finalist by email/phone within two days of their selection. If a finalist is unable to be contacted within five days on the email address or phone number provided, that chef's place as a finalist may be forfeited at Silver Fern Farms' discretion.
12. Finalists must be available to be photographed from 18 to 27 April 2018. This will take place in the chef's restaurant.
13. Finalists agree to have their dish available on their menu through to 31 July 2018. All finalists' dishes will be promoted in media by Silver Fern Farms from 1 May 2018 to 30 July 2018 or as otherwise agreed.
14. Finalists agree to have their entry dish judged again in the second phase of judging to determine a winner. Judging will take place between 7 and 27 May 2018 at an agreed date/ time and entrants will again provide two entry dishes (only) free of charge.
15. Finalists must be available to attend a finalist event held in June 2018 in Auckland, where the winners will be announced. Travel and accommodation costs will be organised and met by Silver Fern Farms for the finalist and their plus one.
16. All entrants agree to promote Silver Fern Farms product when discussing the competition.
17. The winner will be given the title Silver Fern Farms Restaurant Awards Chef of the Year 2018 and will be promoted as the winner of the com-

petition and holder of this title by Silver Fern Farms throughout 2018. Silver Fern Farms may provide further prizes at its absolute discretion.

#### General

1. Only correct and valid entries will be accepted. No responsibility is accepted for the non-receipt of an entry.
2. If any entrant or restaurant fails to comply with these Terms and Conditions then that entrant's entry may be cancelled at Silver Fern Farms' absolute discretion.
3. If this promotion is interfered with in any way or is not capable of being conducted as anticipated due to any reason beyond the reasonable control of Silver Fern Farms then Silver Fern Farms reserves the right at its sole discretion to modify, suspend, terminate or cancel the competition as is appropriate in the circumstances.
4. Except for any liability that cannot be excluded by law, Silver Fern Farms (including its officers, employees and agents) excludes all liability (including negligence) to any person for any loss or damage (including loss of opportunity), whether direct, indirect, special or consequential arising in any way out of this competition.
